Supervision

Technical information about this website's accessibility

This website is partially compliant with the law on accessibility to digital public, due to the non-compliances and exemptions listed below.

• Some images do not have a text alternative, so people using a screen reader cannot access the information.

- The main menu on the website includes unapproved aria elements and cannot be properly navigated using the arrow keys.
- There are elements on the website with insufficient contrast, which means they may be difficult to read for people with visual impairment.
- The font size of some texts on the website is too small, which means they may be difficult to read for people with visual impairment.
- Some images images are used as links but have no text.
- The website is accessible when zooming to 200 percent, except for the
 contact pop-up where the buttons "Felanmälan parkering" and
 "Felanmälan lägenhet" are no longer visible. However, these buttons are
 accessible via the page footer. Magnification of more than 200 percent
 may cause incorrect position of some graphic elements, or that they are
 not visible at all.

Disproportionate burden

Lunds Kommuns Parkerings AB pleads exemption from compliance with the accessibility requirement as it imposes a disproportionate burden, regarding the following:

• Enabling increased distance between characters, rows, paragraphs, and words.

Motivation: Enabling dynamic adjusting of distance between characters, rows, paragraphs, and words would demand comprehensive reprogramming of the entire web page, and we need more time to implement this functionality.

Developing the system to be manageable only using the keyboard.
 Motivation: This would demand comprehensive reprogramming of the entire web page, and we need more time to implement this functionality.

• Providing users with multiple ways of navigation.

Motivation: This would demand comprehensive reprogramming of the entire web page, and we need more time to implement this functionality.

Our ambition is to fix all known accessibility deficiencies by 30 September, 2020.

How we tested this website

The external party, Bacill AB, has performed an independent review of the availability of lkpab.se by using "WAVE Web Accessibility Evaluation Tool" (https://wave.webaim.org".
